3. A copy of the WERC By-Laws, approved at the Annual Meeting on 10 March.

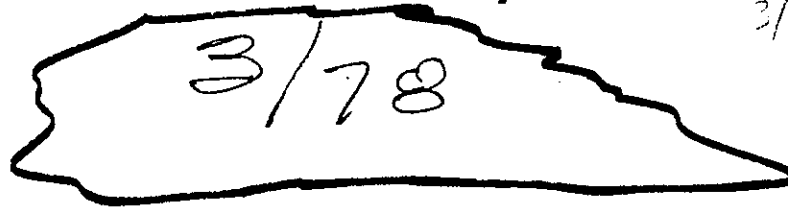
